#### What data do we collect?

We collect your personal data. Personal data means any data which relates to an individual and which can be used to identify them, for example:

- Personally Identifiable Information: This data is provided by you for your registration and use of other services name, email address, telephone number, country, state, etc.
- Browser and Visit Information: This data is provided by your browser and the visits you have made to our website - browser type, operating system, IP address, demographics, etc.
- Cookie information: See the Cookie Policy for cookie information.

However, you can browse our website without providing us with your personal information.

#### How do we collect and use your personal data?

Collection of personal data

We collect your data in the following ways:

- When you register online or place an order for products or services
- When you complete a survey, provide feedback about our products or services or by email
- By using your browser's cookies when you visit our website

Use of personal data

We use your personal data for the following purposes:

- To create and manage your account on our website
- To process information relating to your orders and refunds
- To identify you once you have registered on our site
- To provide you with a better user experience and service
- To contact you and respond to your questions and comments
- To understand which sections of the website are visited and how often

#### Data used for marketing purposes or shared with third parties

Data used for marketing purposes

Our organization would like to send you marketing emails for products, services and offers that you might like and that are tailored to your preferences. You have the right, at any time, to prevent our organization from contacting you. You can at any time refuse to receive our marketing emails at a later date.

Sharing data with third-party sites

Our organization will never share your personal data with third party sites without first obtaining your authorization. However, we share your personal data within the organization, with business partners and with authorized third-party services.

### What are your data protection rights?

We would like to ensure that you are fully aware of your data protection rights. Each user has the following rights:

- The right of access: you have the right to request copies of your personal data that has been provided to us.
- The right to rectification: you have the right to ask us to correct personal data that you believe needs to be corrected. You also have the right to complete data that you consider incomplete.
- The right to erasure: you have the right to ask us to erase all your personal data at any time.
- The right to object: you have the right to object to the processing of your personal data by our organization, under certain conditions.
- The right to data portability: you can at any time ask us to transfer your personal data to any other organization or directly to you, under certain conditions.

#### **Privacy Policy for Other Hyperlinked Websites**
